

# WORLD OF OUTLAWS CRAFTSMAN CLUB SWEEPSTAKES OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. TO ENTER YOU MUST BE A LEGAL U.S. RESIDENT AND 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. VOID IN PUERTO RICO, AND WHERE PROHIBITED OR RESTRICTED BY LAW.**

**Promotion Period:** The World of Outlaws Craftsman Club Sweepstakes ("Sweepstakes") begins at 12:00 P.M. Eastern Time ("ET") on **4/4/17** and ends at 11:59 P.M. ET on **11/4/17** ("Promotion Period"). The winner will be selected in a random drawing from among all eligible entries received.

**ELIGIBILITY:** The Sweepstakes is open only to individuals 18 years of age or older at time of entry and who are legal residents of the 50 United States or Washington D.C. Void in Puerto Rico, and where prohibited or restricted by law. Once you have completed the entry form in its entirety, click submit to receive one (1) entry into the Sweepstakes.
2. You may also enter the Sweepstakes at participating World of Outlaws Craftsman® Sprint Car Series and World of Outlaws Craftsman® Late Model Series events between April 4, 2017 and November 4, 2017 by completing an official entry form with your name, address, email address and phone number to receive one (1) entry into the Sweepstakes.

Only complete and valid Entries will be eligible. Maximum of one (1) entry per person, per email address, per day, per method of entry (from #1 and #2 above), for a total maximum of two (2) entries per person, per email address per day.
