



Spectator Guidelines “Snapshot”

- i. If you are sick or display symptoms of COVID-19, **STAY HOME**
- ii. Fans are encouraged to purchase tickets in advance. Tickets and Pit Passes will be available at the gate.
- iii. Onsite Ticket sales will open at 4pm. Pit Gate will open at 2pm
- iv. ALL Attendees can pay using cash or Credit/Debit card for Ticket/Pit Pass purchases, Concessions and Merchandise purchases.
- v. Anyone without a ticket can purchase and enter at 3pm. Fans are permitted to leave and re-enter the facility with proper credentials.
- vi. Upon arrival to the Facility you should be prepared for a COVID-19 Screening up to and including a Temperature Test. Anyone showing symptoms of COVID-19 or having a temperature over 100.3 degrees will be asked to leave the facility and see a physician.
- vii. Overnight camping is available. This is available in advance or at the gate. Contact the track to reserve a spot.
- viii. **While at the event we recommend ALL Spectators wear a cloth Face cover at ALL times. Anyone getting Concessions MUST have a face cover.**
- ix. ALL Attendees **MUST follow CDC Guidelines** throughout the entire event from entry onto the facility until exit. In addition to wearing cloth face covers, we recommend Social-Distancing (*6' separation*) and washing your hands every 20 minutes throughout the event. Fans should follow social-distancing guidelines while in line for tickets, merchandise and concessions. Fans should also leave 6' in between groups in grandstands.
- x. Concessions will be available.
- xi. ALL Attendees must exit the facility no later than 1-hour following the Feature Checkered Flag unless camping overnight onsite.

Exhibit C – *Spectator Guidelines*

In preparing for the #ReturntoRacing you will read about **[CLEAN-COVER-CONFINE]**. As the country, and motorsports in particular, gradually eases back into business it is important to remember that everyone needs to remain aware of reducing and eventually eliminating the spread of COVID-19. Keeping these three simple words in mind as you go about your business will enable all of us to work toward the time when tracks will reverberate to the sound of race cars and will be full of cheering race fans.

1. PRE-EVENT

a. HEALTH

- i. If Attendee is sick or displays symptoms of COVID-19, STAY HOME
 - a. Covid-19 Symptoms includes Fever, Muscle Pain, Cough, Headache, Shortness of breath or difficulty breathing, Sore Throat, Loss of Taste or Smell, Chills or Repeated Shaking with Chills

b. PERSONAL HYGEINE

- i. Attendee should wash hands with soap & water every 20-min. throughout the day...Sanitizer should ONLY support hand-washing, not take the place. **[CLEAN]**
- ii. Attendee should avoid touching their face. **[CLEAN-COVER]**

c. PREPARATION

- i. ALL Attendees should be prepared with cash and debit/credit card for onsite payment. Ticketing, Concession and Merchandise will accept cash and Credit/Debit Cards. There will be an ATM onsite.
- ii. Attendees are required to bring a cloth Face Cover (*or similar*). PLEASE DO NOT use any medical-style Face Masks or Gloves that would otherwise be used by a health care worker. **[COVER]**
- iii. Concession Stands will be open in the Grandstand area.

d. CONSIDERATIONS

- i. If you live with someone over the age of 65 or with underlying medical conditions, you should consider staying home or be prepared to self-quarantine upon your return if you become sick or show COVID-19 Symptoms. **[CONFINE]**

- i. Attendee should travel and attend with household contacts if possible. **[CONFINE]**

2. EVENT EXPERIENCE

a. ARRIVAL

- i. Spectators will not be allowed to enter the facility before 2pm in the Pits or 4pm in the Grandstands.

- ii. Upon arrival to the facility you should be prepared for a COVID-19 Screening up to and including a Temperature Test.
 - a. Temperature scanners will be used to test all Attendees entering the Facility. Any Attendee with a temperature of 100.4 degrees or higher will not be allowed into the Facility.
- b. **TRANSACTIONS**
 - i. Cash and Credit/Debit Cards will be accepted at the Ticket booth, Pit Booth, and Concession stands.
- c. **MERCHANDISE**
 - i. World of Outlaws Official merchandise and Platinum team members merchandise will be available in the Fan Midway. Merchandise transactions are recommended by Credit or Debit Card, but cash will be accepted.
- d. **SOCIAL DISTANCING**
 - i. Attendees are recommended to practice Social-Distancing at ALL times. When lining up to enter the Facility, buy Merchandise, purchase tickets or for Concessions, Attendees should observe the pre-marked lines indicating six-foot spacing. **[CONFINE]**

- e. **PERSONAL HYGEINE**
 - i. There will be hand-sanitizing stations located throughout the Facility. Attendees should wash hands with soap and water every 20-minutes throughout the day...Sanitizer should ONLY support hand washing, not take the place of. **[CLEAN]**
 - ii. It is required that Spectators wear cloth Face Cover (*or similar*) at ALL times. PLEASE DO NOT use any medical-style Face Masks or Gloves that would otherwise be used by a health care worker. **[COVER]**
 - iii. Attendee should avoid touching their face. **[CLEAN-COVER]**
 - iv. Attendee should cover ALL coughs & sneezing. **[COVER]**

f. **SEATING**

- i. All seating is General Admission and on a first comes biases.

g. **CONCESSIONS**

- i. Concession stands will be open.

3. POST-EVENT PLAN

a. **EXIT**

- i. ALL Attendees MUST EXIT 1-hour after the Feature if you are not staying onsite.

b. **HEALTH**

- i. If an attendee feels any COVID-19 Symptoms within 72 hours of the event we ask you to contact the event organizer and see your primary doctor. **(CONFINE)**
 - a. Covid-19 Symptoms includes Fever, Muscle Pain, Cough, Headache, Shortness of breath or difficulty breathing, Sore Throat, Loss of Taste or Smell, Chills or Repeated Shaking with Chills
